#### RESOLUTION I

# PERMANENT COMMITTEE ON REVISION OF THE CONSTITUTION OF THE PAN AMERICAN SANITARY ORGANIZATION

#### WHEREAS:

The Directing Council at its V Meeting, resolved (Resolution XIV) to establish a permanent committee of the Executive Committee for the purpose of studying the revision of the Constitution of the Pan American Sanitary Organization.

THE EXECUTIVE COMMITTEE,

#### RESOLVES:

- 1. To appoint the Representatives of Chile, the Dominican Republic and the United States as the Permanent Committee to study the revision of the Constitution of the Pan American Sanitary Organization, and to prepare a report and draft revision to be submitted to the Directing Council at its VI Meeting.
- 2. To instruct the Director of the Pan American Sanitary Bureau to transmit to the above-mentioned Permanent Committee the existing documents on this subject, as well as any that may be received later, and to make available the cooperation of the necessary technical staff of the Bureau in order to facilitate the work of the said Committee.

## RESOLUTION II

AMENDMENTS TO THE RULES OF PROCEDURE OF THE DIRECTING COUNCIL

#### WHEREAS:

The Directing Council at its V Meeting, requested (Resolution XXXVIII) the Executive Committee to submit its recommendations on the proposed amendments to the Rules of Procedure of the Directing Council; and
