

FINAL ACT OF THE XII PAN AMERICAN SANITARY CONFERENCE

The XII Pan American Sanitary Conference began at Caracas on the 12th of January, 1947, with a Preparatory Session, at which the President of the Conference was elected. Dr. Armando Castillo Plaza, President of the Organizing Committee, was named by acclamation, but declined, explaining that the Presidency of this Committee had actually passed into the hands of the highest dignitary of public health in the Republic of Venezuela, Dr. Edmundo Fernández, Minister of Health and Social Security because of which, he asked that Dr. Fernández be appointed President of the Conference. This suggestion was accepted by acclamation and at the same time it was provided that on those occasions when Dr. Fernández could not occupy the Presidency, Dr. Castillo Plaza would serve as Alternate.

Drs. Santiago Ruesta and Arístides Moll were selected as Secretaries General, both of whom were already acting in this capacity in the Preparatory Session, in accord with the provisional rules of the Conference.

His Excellency, Sr. Rómulo Betancourt, Chief of the Governing Committee of the Republic of Venezuela, was acclaimed Honorary President, and the Presidents of the American Republics, Honorary Vice-Presidents of the Conference.

The formal Inaugural Session took place on the evening of the 12th of January and was presided over by his Excellency, Sr. Rómulo Betancourt, Chief of the Governing Committee of Venezuela, who invited the following to accompany him: Dr. Edmundo Fernández, Acting Minister of Health and Social Security and President of the Conference; Dr. Hugh S. Cumming, Director of the Pan American Sanitary Bureau; Dr. Armando Castillo Plaza, President of the Organizing Committee; His Excellency, the Ambassador of Bolivia, Dr. Luis Felipe Lira Girón; the Minister of Hygiene of the Republic of Colombia, Dr. Jorge Bejarano; the Minister of Hygiene and Social Service of the Republic of Ecuador, Dr. Adolfo Jurado; and Drs. Santiago Ruesta and Arístides Moll, Secretaries General of the Conference, while the other Chiefs of Delegation occupied seats of honor on the stage.

His Excellency, the President of the Governing Committee of Venezuela, opened the session, during which talks were given also by Drs. Edmundo Fernández, Armando Castillo Plaza and Hugh S. Cumming. These are included in the General Proceedings of the Conference.

VOTES AND RESOLUTIONS

CSP12.R1 EN PAN AMERICAN SANITARY CODE

Taking into consideration the statement of the delegation of the United States that, having received this draft just shortly before the Conference, it had not had time to study it in detail, and considering the possibility that the United States may not be the only country in this situation, The XII Pan American Sanitary Conference

RESOLVES (1) To defer approval of the draft revision of the Pan American Sanitary Code presented by the Pan American Sanitary Bureau, and to recommend that the modifications therein approved by the respective Sub-Committee should be submitted to all the countries for study by their experts, with the request that observation and suggestions be forwarded to the Pan American Sanitary Bureau so that they may be taken into account at the next meeting of the Directing Council, which will be called for that purpose within the year ;

(2) Expresses the hope that final action will be taken at the said meeting;

(3) Tenders a vote of thanks to the Committee which prepared the draft of the code.
