ELECTION OF THREE MEMBER GOVERNMENTS TO THE EXECUTIVE COMMITTEE ON THE TERMINATION OF THE PERIODS OF OFFICE OF NICARAGUA, TRINIDAD AND TOBAGO, AND URUGUAY

Pursuant to Article 15-A of the Constitution of the Pan American Health Organization, "The Executive Committee shall be composed of nine Member Governments of the Organization elected by the Conference or the Council for overlapping periods of three years. Each of the elected Member Governments shall be entitled to designate one representative to the Executive Committee. Each representative may be accompanied by one or more alternates and advisers. A Member Government shall not be eligible for reelection to the Executive Committee until one year has elapsed since the expiration of its term of office."

The following table shows the composition of the Executive Committee with the expiration dates of the terms of the present Members.
