REQUEST OF THE GOVERNMENT OF SPAIN FOR OBSERVER STATUS IN THE PAN AMERICAN HEALTH ORGANIZATION

The Director transmits to the XXVII Meeting of the Directing Council, for its consideration, the official letter sent by the Minister of Foreign Affairs of Spain requesting the admission of Spain to PAHO as an observer country. The Constitution of PAHO makes no provision for observer countries from other Regions of the world. In the OAS, however, which recognizes PAHO as a Specialized Agency of the Inter-American System, there are precedents in this regard which the Directing Council should bear in mind in considering this matter.

The Director of the Pan American Sanitary Bureau has the honor to transmit to the Directing Council in its XXVII Meeting the letter dated 4 June 1980 in which His Excellency the Minister of Foreign Affairs of Spain, Mr. Marcelino Oreja Aguirre, requests on behalf of his Government the admission of Spain as an observer country to the Pan American Health Organization.

This request was presented personally by Mr. Eduardo de Zulueta, Ambassador, Permanent Observer of Spain to the Organization of American States, to the Executive Committee of PAHO in its 84th Meeting. The Executive Committee took due note of the request and decided to place it on the agenda of the XXVII Meeting of the Directing Council.

Copies of the letter from the Minister of Foreign Affairs and of the reply of the Director of the Pan American Sanitary Bureau are annexed to the present document.

It may be noted that the Constitution of PAHO says nothing about observer countries in other Regions of the world. Resolution XV of the V Directing Council<sup>1</sup> refers to participation in the meetings of the Directing Council by certain Members of the World Health Organization not having their seats of government within the Western Hemisphere, but refers in operative paragraph 2 to countries which consider certain territories or groups of territories in the Western Hemisphere as part of their national territory, or are responsible for the conduct of the international relations of territories or groups of territories within the Western Hemisphere.

Moreover, the Organization of American States, which in the Agreement signed on 23 May 1950<sup>2</sup> recognizes the Pan American Health Organization as an Inter-American Specialized Organization, has adopted special resolutions on observer countries not having their seats of government within the Western Hemisphere.<sup>3</sup> The Governments of these countries are represented by observers to the Permanent Council and General Assembly of the OAS.

For the information of the Directing Council, it is added that Spain was admitted as a Permanent Observer to the Organization of American States by Resolution CP/Res. 54(62/72) of 2 February 1972.
