Topic 4: PROGRAM AND BUDGET OF THE PAN AMERICAN SANITARY BUREAU FOR 1952

Background

At its 13th Meeting, the Executive Committee reviewed in detail the Program and Budget of the Pan American Sanitary Bureau for 1952 submitted by the Director. After lengthy and careful consideration, the Executive Committee determined that it would be inappropriate to increase the total amount assessable against Member Nations over the amount established in respect to the year 1951.

The Committee instructed the Director to revise the Proposed Program and Budget for 1952 in accordance with their changes specifying that \$43,000 should be provided for the training and fellowships program and that the amount required to subsidize the celebration of the First Inter-American Congress on Public Health should be allocated from the sum of \$65,922 allotted for the VI Meeting of the Directing Council.\*

The Director has acted in conformity with these instructions and, in addition, has met the further requirement of transmitting the Proposed Program and Budget of the Executive Committee to the Member Governments thirty days prior to the meeting of the Council.
