The provisional agenda (Document CE98/1) was unanimously adopted.

DECISIONS

- 1. The terms of office of Canada and Dominica having expired, the Executive Committee elected Ecuador and Saint Lucia members of the Award Committee of the PAHO Award for Administration.
- 2. The term of office of Canada having expired, the Executive Committee elected the United States of America a member of the Subcommittee on Planning and Programming.
- 3. The term of office of Canada having expired, the Executive Committee elected Brazil a member of the Special Subcommittee on Women, Health and Development.
- 4. The terms of office of Costa Rica and Dominica having expired, the Executive Committee elected Colombia and Saint Lucia members of the Standing Subcommittee on Inter-American Nongovernmental Organizations.
- 5. The Executive Committee approved the Director's proposal to postpone the meeting of the Subcommittee on Planning and Program from December 1986 to March 1987 for reasons of practical efficiency.
