REPORT ON THE COLLECTION OF QUOTA CONTRIBUTIONS

The Director has the honor to present reports on the status of quota contributions as of 31 December 1993 and as of 17 June 1994, respectively.

A table showing the status of quota contributions as of 31 December 1993 was presented to the Executive Committee in June (Doc. CE113/21, see Annex I). Total contributions received during 1993 were \$78,761,395, of which \$47,324,572 related to 1993 assessments and \$31,436,823 to assessments for years prior to 1993. Collections are also shown by Member State by date of payment.

An updated table on the status of quota contributions as of 17 June 1994 as submitted to the 113th Meeting of the Executive Committee (Doc. CE113/21, Add. I) is attached as Annex II. Collections are also shown by Member State and by date of payment. This table indicates that only \$20,277,223 in quota contributions had been received as of 17 June 1994 against quota balances remaining due as of 1 January 1994. Efforts are continuing to encourage Member States to make prompt payment of their outstanding quota contributions.

To provide the XXIV Pan American Sanitary Conference with the latest information on contributions, an updated status report will be issued prior to the meeting.

The Executive Committee at its 113th Meeting considered the status of quota contributions and the special report of the Director on countries in arrears in an amount exceeding the sum of their quota for two full years and approved Resolution CE113.R1, which reads as follows:

THE 113th MEETING OF THE EXECUTIVE COMMITTEE,

Having considered the report of the Director on the collection of quota contributions (Document CE113/21 and Add. I) and the report provided on Member

Governments in arrears in the payment of their quota contributions to the extent that they can be subject to the application of Article 6.B of the Constitution of the Pan American Health Organization;

Noting the provisions of Article 6.B of the PAHO Constitution relating to the suspension of voting privileges of Member Governments that fail to meet their financial obligations and the potential application of these provisions to nine Member Governments; and


Noting with concern that there are 25 Member Governments that have not made any payments towards their 1994 quota assessments and that amounts collected for 1994 assessments amount to only 7% of total assessments,

RESOLVES:

- 1. To take note of the report of the Director on the collection of quota contributions (Document CE113/21 and Add. I).
- 2. To thank the Member Governments that have already made payments for 1994 and to urge the other Member Governments to pay their outstanding quota contributions as soon as possible.
- 3. To recommend to the XXIV Pan American Sanitary Conference that the voting restrictions contained in Article 6.B of the PAHO Constitution be strictly applied to those Member Governments that by the opening of that meeting have not made additional and substantial payments towards their payment commitments.
- 4. To request the Director to continue to inform the Member Governments of any balances due and to report to the XXIV Pan American Sanitary Conference on the status of the collection of quota contributions.

REPORT ON THE COLLECTION OF QUOTA CONTRIBUTIONS

The Director has the honor to present reports on the status of quota contributions as of 31 December 1993 and as of 30 April 1994, respectively.

In Annex 1, there is a table showing the status of quota contributions as of 31 December 1993. Total contributions received during 1993 were \$78,761,395, of which \$47,324,572 related to 1993 assessments and \$31,436,823 to assessments for years prior to 1993. Collections are also shown by Member State and by date of payment.

To provide the Executive Committee with more recent information, an updated table on the status of quota contributions as of 30 April 1994 is attached as Annex 2. Collections are also shown by Member State and by date of payment. This table indicates that only \$19,391,057 in quota contributions has been received as of 30 April 1994 against quota balances remaining due as of 1 January 1994. Efforts are continuing to encourage Member States to make prompt payment of their outstanding quota contributions.

By Resolution I, the XXXVII Meeting of the Directing Council requested the Director to monitor carefully the implementation of the special agreements made by Member States for the payment of their quota arrears and to advise the Executive Committee of Governments' compliance with their quota payment commitments. A special report on these quota contribution situations will be presented to the 113th Meeting of the Executive Committee.

To provide the Executive Committee with the latest information, a revised report on the status of quota contributions as of 17 June 1994 is presented.

PAN AMERICAN HEALTH ORGANIZATION
