**REPORT OF THE AWARD COMMITTEE OF THE PAHO AWARD FOR

THE 111th MEETING OF THE EXECUTIVE COMMITTEE,

Having examined the report of the Award Committee of the PAHO Award in Administration, 1993 (Document CE111/7, ADD. I); and

Bearing in mind the provisions of the Procedure and Guidelines for conferring the PAHO Award for Administration as approved by the XVIII Pan American Sanitary Conference (1970) and amended by the XX Pan American Sanitary Conference (1978) and by the XXVII Meeting of the Directing Council (1980),

RESOLVES:

1. To note the decision of the Award Committee to confer the PAHO Award for Administration, 1993 on Dr. Georgina Velásquez Díaz of Mexico for her contribution to the organization and consolidation of the administrative infrastructure and health services of the Mexican Institute of Social Security Solidarity Program.
