Topic 3: ADOPTION OF THE AGENDA AND OF THE PROGRAM OF SESSIONS

Agenda

Pursuant to Articles 10 and 11 of the Rules of Procedure, a provisional agenda for the present meeting was prepared by the Director and transmitted to the Member Governments with the letter of convocation of 15 February 1956, in which it was stated that the agenda would include any other topics proposed by the Members not later than twenty-one days prior to the meeting. A revised provisional agenda, including two additional topics proposed by the Government of Cuba, was transmitted to the Member Governments on 27 April 1956. The Director, therefore, has the honor to present the attached draft agenda containing fourteen topics for consideration by the Executive Committee (Annex I).

Program of Sessions

In accordance with Article 12 of the Rules of Procedure, the Director has prepared the attached program of sessions for consideration by the Executive Committee (Annex II).

One of the special functions of the Committee, pursuant to Article 12-C of the Constitution, is "to prepare with the cooperation of the Director of the Pan American Sanitary Bureau a proposed budget for consideration by the Council." In accordance with the practice established by the Committee in previous years, provision is made in the proposed program for a general discussion in plenary session of the Proposed Program and Budget for 1957, which could be followed by the establishment of a working party to study this topic and prepare a report for consideration by the Committee.

In accordance with the proposed program, the meeting would end two days earlier than originally scheduled. The afternoon of Friday, 8 June, has been left free for a visit to the Bureau by the members of the Committee.
