REPORT ON THE COLLECTION OF QUOTA CONTRIBUTIONS

In Document CSP17/24 the status of quota contributions was presented as of 25 August 1966. To provide the Pan American Sanitary Conference with the latest information as of 23 September 1966 the corresponding table is attached.

As of the date of this revision the situation with respect to countries in arrears more than two years is changed from CSP17/24 as follows:

ARGENTINA: A cable from the PAHO Zone Office dated 22 September 1966 reported that the Government of Argentina transferred \$267,734 on twenty-first September and that a further amount was being transmitted on the twenty-second. The amount reported transferred on 21 September when received will be sufficient to cancel the quotas due in respect of 1963 and Argentina will no longer be in arrears more than two years.

PARAGUAY: The payments reported in the attached table have cancelled the quotas due in respect of 1962 and 1963. Consequently, Paraguay is no longer in arrears more than two years.
