ELECTION OF THREE MEMBER STATES TO THE EXECUTIVE COMMITTEE ON THE EXPIRATION OF THE PERIODS OF OFFICE OF GUATEMALA, TRINIDAD AND TOBAGO, AND UNITED STATES OF AMERICA

- 1. Article 15.A of the Constitution of the Pan American Health Organization provides that the Executive Committee will be composed of nine Member States of the Organization elected by the Pan American Sanitary Conference (Conference) or the Directing Council for overlapping periods of three years. A Member State will not be eligible for re-election to the Executive Committee until one year has elapsed since the expiration of its term of office.
- 2. The following list shows the composition of the Executive Committee with the expiration dates of the terms of the present Members:

Antigua and Barbuda	September 2018
Argentina	September 2018
Chile	September 2018
Brazil	September 2019

Panama	September 2019

- 3. It is incumbent upon the Conference, in conformity with Article 4.D of the Constitution of PAHO, to elect the Member States to replace Guatemala, Trinidad and Tobago, and United States of America, whose periods of office on the Committee expire as of the close of this Pan American Sanitary Conference.
- 4. For the information of the Conference, the chart in Annex B shows the membership of the Executive Committee since 1994.

5. Once three Member States have been elected, the Conference is requested to consider adoption of the proposed resolution in Annex A.
