DRAFT PROGRAM OF SESSIONS OF THE XIV PAN AMERICAN SANITARY Topic 8: CONFERENCE

On the basis of the points set forth in Document CE22/13, attached, the Director presented to the Executive Committee, for consideration at it 22nd Meeting, the Draft Program of Sessions of the XIV Pan American Sanitary Conference (Document CE22/13, Annex I and II). After studying the Draft Program, the Executive Committee adopted the following resolution:

"RESOLUTION IV

"THE EXECUTIVE CONDITTEE,

HAVING STUDIED Document CE22/13 on the Draft Program of Sessions of the MIV Pan American Sanitary Conference and Annexes I and II thereto; and

CONSIDERING that it is necessary to organize in advance the secretariat services for the next meeting of the Pan American Sanitary Conference, and recognizing that the organization of these services is dependent on the number and type of sessions to be held daily during the Conference,

RESOLVES:

1. To approve Document CE22/13 and Annexes I and II thereto, relating to the Draft Program of Sessions of the XIV Pan American Sanitary Conference, which will be transmitted to the Member Governments, to the Committee designated by the Government of Chile to cooperate in the organization of the XIV Pan American Sanitary Conference, and to the General Committee of the Conference.

2. To instruct the Director to take the necessary measures to organize the Secretariat so as to meet adequately the needs of the sessions that it is anticipated will be held, and provide the services indicated in the Draft Program of Sessions."

Topic 16: DRAFT PROGRAM OF SESSIONS OF THE XIV PAN AMERICAN SANITARY CONFERENCE

The Proposed Rules of Procedure of the XIV Pan American Sanitary Conference provide that "to allow for proper discussion of the items of the agenda the Director of the Pan American Sanitary Bureau shall formulate a program for the sessions". Pursuant to this provision the Director has prepared the attached Draft Program of Sessions (Annex I) which is based on the draft agenda for the XIV Conference (Document CE22/9) and the proposal contained in Document CE22/8 for technical discussions at the Conference in its role of "forum for the interchange of information and ideas". The Draft Program of Sessions covers the whole period of the Conference and indicates insofar as possible the sessions that will be held on the days in which the Conference is meeting.

The work of the Conference will be divided into plenary sessions, sessions of two main committees and sessions of working parties. As it is a function of the General Committee to propose to the Conference the topics to be discussed by the committees, the distribution of topics has not been indicated in the Program, although it is assumed that Committee I (Technical Matters) will be entrusted with the technical discussions.

Within Committee I three working parties will be established to proceed with the technical discussion of the three topics selected by the Executive Committee, as proposed in Document CE22/8. Should Committee II decide to establish one or two working parties, some of the time allotted in the program for meetings of the Committee would be utilized for sessions of the working parties.

With such modifications as the Executive Committee may desire to introduce the Draft Program of Sessions will be distributed to the Member Governments, made available to the Committee designated by the Government of Chile to cooperate in the organization of the XIV Pan American Sanitary Conference, and presented to the General Committee for study and transmittal to a plenary session of the Conference. The Pan American Sanitary Bureau, in cooperation with the Chilean Committee, pursuant to Article 7-B of the

Constitution, will take such measures as are necessary to organize the meeting before the Conference convenes, being guided by the Draft Program of Sessions approved by the Executive Committee. The measures to be taken include the determination of the number of conference rooms required for the sessions, the type and quantity of simultaneous interpretation equipment to be installed, and the number of interpreters, translators, précis writers and other temporary conference staff to be recruited. These measures depend primarily on the number of sessions which it is anticipated will take place simultaneously on any given day. Annex II shows graphically the number and type of sessions to be held daily during the Conference and the type of secretariat services to be provided with regard to working documents, interpretation and minutes, for each of the sessions.

In view of the above, the Director has the honor to present the following proposal to the Executive Committee:
