AGENDA

The provisional agenda (Document CE110/1) was adopted.

DECISIONS

- 1. The Executive Committee elected Belize and Mexico to the Subcommittee on Planning and Programming, upon the expiration of the terms of office of Barbados and Brazil on the Executive Committee.
- 2. The Executive Committee elected Peru to the Special Subcommittee on Women, Health, and Development, upon the expiration of the term of office of Brazil on the Executive Committee.
- 3. The Executive Committee elected Argentina and Cuba to the Standing Subcommittee on Inter-American Nongovernmental Organizations in Official Relations with PAHO, upon the expiration of the terms of office of Brazil and Haiti on the Executive Committee.

- 4. It was decided that the next meeting of the Subcommittee on Planning and Programming would be held at Headquarters on 17 and 18 December 1992, and that it would meet again from 7 to 9 April 1993.
- 5. It was decided that the next meeting of the Special Subcommittee on Women, Health and Development would be held at Headquarters from 5 to 7 April 1993.
- 6. It was decided that the 111th Meeting of the Executive Committee would be held at Headquarters from 28 June to 2 July 1993.

RESOLUTIONS

During the single plenary session the Executive Committee adopted the following resolution:

THE 110th MEETING OF THE EXECUTIVE COMMITTEE,

Bearing in mind Article 14.A of the Constitution of the Pan American Health Organization and Rule 1 of the Rules of Procedure of the Directing Council,

RESOLVES: CE110.R1

To authorize the Director to convoke the XXXVII Meeting of the Directing Council of PAHO, XLV Meeting of the Regional Committee of WHO for the Americas, to meet at the Headquarters' building in Washington, D.C., from 27 September to 1 October 1993.

IN WITNESS WHEREOF, the Chairman of the Executive Committee and the Secretary ex officio, Director of the Pan American Sanitary Bureau, sign the present Final Report in the English and Spanish languages, both texts being equally authentic.
