

REPORT ON THE COLLECTION OF QUOTA CONTRIBUTIONS

The Director has the honor to present a report on the status of quota contributions as of 30 April 1993.

In the Interim Financial Report of the Director for the Year 1992 (Official Document 255) there is presented a table showing the status of quota contributions as of 31 December 1992. Total contributions received during 1992 were \$71,953,758, of which \$47,097,052 related to 1992 assessments and \$24,856,706 related to assessments for years prior to 1992.

To provide the Executive Committee with more recent information, an updated table on the status of quota contributions as of 30 April 1993 is attached as Annex I. Collections are also shown by Member Country and by date of payment in Annex II. Annex I indicates that only \$31,084,527 in quota contributions has been received as of 30 April 1993 against quota balances remaining due as of 1 January 1993. Efforts are continuing to encourage Member Countries to make prompt payment of their outstanding quota contributions.

By Resolution I, the XXXVI Meeting of the Directing Council requested the Director to monitor carefully the implementation of the special agreements made by Member Governments for the payment of their quota arrears and to advise the Executive Committee of countries' compliance with their quota payment commitments. A special report on these quota contribution situations will be presented to the 111th Meeting of the Executive Committee.
