Topic 9: REVISED DRAFT AGENDA OF THE XIV PAN AMERICAN SANI-TARY CONFERENCE, VI MEETING OF THE REGIONAL COMMIT-TEE OF THE WORLD HEALTH ORGANIZATION

Resolution VIII, adopted by the Executive Committe at its 22nd Meeting held in Washington, D.C., April 1954, approved the Draft Agenda of the XIV Pan American Sanitary Conference, comprising 29 topics, as presented in Document CE22/9, Annex I.

That Draft Agenda has been modified as follows:

- l. Topic 24, dealing with the Pan American Bromatological Code, was withdrawn by the Government of Argentina, which had proposed it. In its place was inserted the topic "Treponematoses", proposed by the Government of Chile, with these three subtopics:
 - (i) Results obtained from epidemiological investigations of the treponematoses and their control with antibiotics
 - (ii) Mass treatment of syphilis, yaws, Cuban pinta, and carate
 - (iii) Health education applied to treponematoses control
- 2. The following subtopics proposed by the Government of Cuba were added to Topic 15, "Revision of the Constitution of the Pan American Sanitary Organization":
 - (a) "Membership and Associate Membership in the Organization" (Document CSP14/38)

(b) "Change in the Names of the Organization, the Conference, and the Bureau; and Change in the Composition and Meetings of the Executive Committee" (Articles 13 and 14 of the present Constitution) (Document CSP14/39).

Moreover, pursuant to the aforesaid Resolution VIII, the Director of the Pan American Sanitary Bureau has included the following topics on the Draft Agenda of the XIV Pan American Sanitary Conference:
