INAUGURATION OF THE MEETING

Dr. Orontés Avilés (Nicaragua), the Acting President of the Executive Committee, opened the meeting and welcomed the Representatives of Guyana, Peru and Venezuela, the Members elected by the Directing Council at its XIX Meeting to fill the vacancies that had occurred on the expiration of the term of office of Brazil, Colombia, and the United States of America.

OFFICERS

On the proposal of the Representative of Uruguay, seconded by the Representatives of Guyana, Mexico, Nicaragua, Peru, Trinidad and Tobago, and Venezuela, Dr. Victorio V. Olguín (Argentina) was unanimously elected Chairman of the Executive Committee.

On the proposal of the Representative of Peru, seconded by the Representatives of Guyana, Mexico, Nicaragua, Trinidad and Tobago, and Venezuela,

Dr. Abelardo Sáenz Sanguinetti (Uruguay) was elected Vice-Chairman of the

Committee.

On the proposal of the Representative of Mexico, seconded by the Representatives of Guyana, Nicaragua, Peru, Uruguay, and Venezuela, Dr. Manuel Angel Cortés Vargas (Costa Rica) was reelected Rapporteur of the Executive Committee.

AGENDA

The provisional agenda prepared for the Meeting (Document CE63/1) was approved.

DECISIONS TAKEN

1. It was decided to take note of the resolutions approved by the <u>CE63 R1</u> Directing Council at its XIX Meeting, XXI Meeting of the Regional Committee of the World Health Organization for the Americas, which were of interest to the Executive Committee, in particular that relating to the Program and Budget Estimates of the Pan American Health Organization for 1971.

- 2. It was decided that the 64th Meeting of the Executive Committee <u>CE63 R2</u> would be held from 29 June to 11 July 1970.
- 3. It was decided to include in the agenda of the 64th Meeting of CE63 R3
 the Executive Committee an item dealing with a review of the Rules of Procedure of the Governing Bodies.

IN WITNESS WHEREOF, the Chairman of the Executive Committee and the Director of the Pan American Sanitary Bureau, Secretary ex officio, sign the present Final Report in the English and Spanish languages, both texts being equally authentic.
