AGENDA

Pursuant to Rule 5 of the Rules of Procedure, the Executive Committee adopted at its first plenary session, held on 25 June 1979, the provisional agenda (Document CE82/1, Rev. 3) submitted by the Director.

STANDING SUBCOMMITTEE ON NONGOVERNMENTAL ORGANIZATIONS

In compliance with operative paragraph 4 of Resolution XX adopted by the XX Pan American Sanitary Conference in 1978, the Executive Committee appointed a standing subcommittee to review the requests of inter-American nongovernmental organizations for the establishment of official relations with PAHO. The members of the Standing Committee on Nongovernmental Organizations are Paraguay, Venezuela and Guatemala.

SUBCOMMITTEE ON PLANNING AND PROGRAMMING

The Executive Committee established a Subcommittee on Planning and Programming to collaborate with the Program Committee of the Pan American Sanitary Bureau and assist the Director in the work of long-term planning and programming. The members of the Subcommittee are the Representatives of Canada and Guatemala.

AWARD COMMITTEE OF THE PAHO AWARD FOR ADMINISTRATION

The Award Committee of the PAHO Award for Administration consisted of Col. Raúl Ampuero Ríos of Perú, who was elected Chairman, and of Dr. Lelio Bringel Calheiros of Brazil and Mr. Hubert Blackett of Trinidad and Tobago.

WORKING PARTY ON THE ESTABLISHMENT OF RELATIONS WITH INTERGOVERNMENTAL ORGANIZATIONS

In accordance with Rule 17 of its Rules of Procedure, the Executive Committee established a working party to consider, and report on, the matter of the establishment of official relations between intergovernmental organizations and PAHO. The Working Party consisted of Dr. Carlos Luis de Paredes (Guatemala), Dr. Rubén Cáceres (Paraguay), and Dr. Jorge Rodríguez Díaz (Venezuela). They were later joined by Dr. Lelio Bringel Calheiros (Brazil).

SESSIONS

The Committee held 13 plenary sessions and a closing session. Six sessions were devoted to a detailed examination of the proposed program and budget estimates of the Organization, prepared by the Director pursuant to Article 14.C of the Constitution. During this study, the Committee was assisted by the Director and the technical staff of the Bureau.

RESOLUTIONS APPROVED

In the course of the Meeting the Committee approved the following 31 resolutions:

RESOLUTION I CE82 R1

DATES OF THE XXVI MEETING OF THE DIRECTING COUNCIL OF PAHO, XXXI MEETING
OF THE REGIONAL COMMITTEE OF WHO FOR THE AMERICAS

THE EXECUTIVE COMMITTEE,

Considering that the Director has proposed the dates 24 September-5 October 1979 for the XXVI Meeting of the Directing Council of PAHO, XXXI Meeting of the Regional Committee of WHO for the Americas; and

Bearing in mind Articles 12.A and 14.A of the Constitution of the Pan American Health Organization and Rule 1 of the Rules of Procedure of the Directing Council,

RESOLVES:

To authorize the Director to convoke the XXVI Meeting of the Directing Council of PAHO, XXXI Meeting of the Regional Committee of WHO for the Americas, to meet at the Headquarters building in Washington, D.C., from 24 September to 5 October 1979.

RESOLUTION II CE82.R2

PROVISIONAL AGENDA OF THE XXVI MEETING OF THE DIRECTING COUNCIL OF PAHO, XXXI MEETING OF THE REGIONAL COMMITTEE OF WHO FOR THE AMERICAS

THE EXECUTIVE COMMITTEE,

Having studied the provisional agenda (Document CD26/1) of the XXVI Meeting of the Directing Council of PAHO, XXXI Meeting of the Regional Committee of WHO for the Americas, drawn up by the Director and presented as annex to Document CE82/4; and

In view of Article 12.C of the PAHO Constitution and Rule 7 of the Rules of Procedures of the Directing Council,

RESOLVES:

To approve the provisional agenda (Document CD26/1) of the XXVI Meeting of the Directing Council of PAHO, XXXI Meeting of the Regional Committee of WHO for the Americas.

RESOLUTION III CE82.R3

COLLECTION OF QUOTA CONTRIBUTIONS

THE EXECUTIVE COMMITTEE,

Having considered the report of the Director on the collection of quota contributions (Document CE82/12 and ADD.);

Noting that, of the three countries with approved payment plans for liquidating their arrears, three had made a payment by the time of the Executive Committee Meeting;

Considering the importance of prompt and full payment of quota contributions to assure the financing of the authorized program and budget and to maintain the Organization in a sound financial position; and

Bearing in mind the provisions of Article 6.B of the Constitution of PAHO relating to the suspension of voting privileges of Governments failing to meet their financial obligations,

RESOLVES:

- 1. To take note of the report of the Director on the collection of quota contributions (Document CE82/12 and ADD.).
- 2. To thank the Governments that have already made payments in 1979, and to urge the other Governments whose legal circumstances so permit to pay their current quotas as early as possible in the year they are due so that the work of the Organization can continue and the financial burden of its program can be spread fairly among all Members.
- 3. To request the Director to continue to inform the Governments of any balances due and to report to the XXVI Meeting of the Directing Council on the status of the collection of quota contributions.

RESOLUTION IV CE82 R4

FINANCIAL REPORT OF THE DIRECTOR AND REPORT OF THE EXTERNAL AUDITOR FOR 1978

THE EXECUTIVE COMMITTEE,

Having examined the Financial Report of the Director and Report of the External Auditor for fiscal year 1978 (Official Document 160);

Bearing in mind the comments made during the discussions in relation to the remarks of the External Auditor; and

Recognizing that the Organization continues to be in sound financial condition,

RESOLVES:

- 1. To take note of the Financial Report of the Director and Report of the External Auditor for fiscal year 1978 (Official Document 160) and to transmit them to the XXVI Meeting of the Directing Council.
- 2. To commend the Director for having maintained a sound financial situation and to thank the External Auditor for the report presented.

RESOLUTION V CE82 R5

FINANCIAL REPORT OF THE DIRECTOR

HOLDING ACCOUNT

THE EXECUTIVE COMMITTEE,

Considering the provisions of Resolution XVI, of the XX Pan American Sanitary Conference;

Having considered the report of the Director which indicates that a surplus of \$1,080,846 in the Working Capital Fund has been transferred to a Holding Account until such time as the Directing Council decides on how to utilize the funds;

Considering the provisions of Resolution XXVII of the XXV Meeting of the Directing Council concerning the Expanded Program on Immunization and the establishment of the Revolving Fund for the Expanded Program on Immunization;

Considering the presentation by the Director on the capitalization requirement for the operations of the Revolving Fund for the Expanded Program on Immunization;

Considering the increasing membership of the Organization and the discussions in the XXV Meeting of the Directing Council on the inadequacy of the seating arrangements in the Conference Room to accommodate the delegations and supporting staff;

Considering the alternatives presented by the Director for renovation of the Conference Room at the Headquarters Building in Washington to provide adequate seating arrangements for the delegations and supporting staff;

Bearing in mind that the Director is conducting a feasibility study for possible purchase of the office building in Mexico City in which the Area II Office rents space; and

Bearing in mind that all Area Office buildings, except in Area II, Mexico City, are owned by the Organization,

RESOLVES:

- 1. To recommend to the Directing Council that the Director be authorized to transfer \$800,000 from the Holding Account to the Revolving Fund for the Expanded Program on Immunization.
- 2. To recommend to the Directing Council that the Director be authorized to use \$150,000 from the Holding Account for the renovation of the Conference Room to provide adequate seating arrangements for the delegations and supporting staff.
- 3. To recommend to the Directing Council that, if the Council decides to proceed with the purchase of an office building in Mexico City, Mexico, as a result of the feasibility study which is now underway, the Council consider the possible application of the balance of \$130,846 in the Holding Account toward the purchase of this office building for the Organization's use.

RESOLUTION VI CE82 R6

STANDING SUBCOMMITTEE ON INTER-AMERICAN NONGOVERNMENTAL ORGANIZATIONS

THE EXECUTIVE COMMITTEE,

Aware of the need to assure the continuity of the new subcommittee's functions by rotating one of its members each year,

To appoint the Representatives of Paraguay, Venezuela and Guatemala as the members of the Standing Subcommittee on Inter-American Non-governmental Organizations for the duration of their respective terms on the Committee.

Considering that the provisional draft of the program and budget has been the subject of further study by the Governments and of consultations with them to determine their latest desires and requirements;

Having carefully examined the proposed program and budget estimates of the Pan American Health Organization for 1980-1981 (Official Document 161);

Noting that the assessments shown on page 7 of Official Document 161 had to be revised since the publication of that document, due to the independence of Dominica and St. Lucia, which were previously included within the United Kingdom's assessment; and

Bearing in mind Article 14.C of the Constitution of the Pan American Health Organization and Article III, paragraphs 3.5 and 3.6, of the PAHO Financial Regulations,

RESOLVES:

To recommend to the XXVI Meeting of the Directing Council that it approve the proposed program and budget estimates of Pan American Health Organization for 1980-1981 by adopting the following appropriation and assessment resolutions:

In establishing the contributions of Member Governments and Participating Governments, their assessments shall be reduced further by the amount standing to their credit in the Tax Equalization Fund, except that credits of those governments who levy taxes on the emoluments received from the Pan American Health Organization by their nationals and residents shall be reduced by the amounts of such tax reimbursements by PAHO.

- 3. That, in accordance with the Financial Regulations of PAHO, amounts not exceeding the appropriations noted under Paragraph 1 shall be available for the payment of obligations incurred during the period 1 January 1980 to 31 December 1981, inclusive. Notwithstanding the provision of this paragraph, obligations during the financial period 1980-1981 shall be limited to the effective working budget, i.e., Parts I-VI.
- 4. That the Director shall be authorized to transfer credits between parts of the effective working budget, provided that such transfers of credits between parts as are made do not exceed 10% of the part from which the credit is transferred. Transfers of credits between parts of the budget in excess of 10% of the part from which the credit is transferred may be made with the concurrence of the Executive Committee. All transfers of budget credits shall be reported to the Directing Council and/or the Conference.

ASSESSMENTS OF THE MEMBER COVERNMENTS AND PARTICIPATING GOVERNMENTS OF THE PAN AMERICAN HEALTH ORGANIZATION

Whereas, Hember Governments appearing in the scale adopted by the Council of the Organization of American States are assessed according to the percentages shown in that scale, in compliance with Article 60 of the Pan American Sanitary Code; and

Whereas, other Member Governments and Participating Governments are assessed on the basis of percentages which would be assigned to such countries if they were subject to the OAS scale; now, therefore,

RESOLUTION XIX CE82.R19

EXTENSION OF HEALTH SERVICES

THE EXECUTIVE COMMITTEE,

Having examined the report of the Director on the program for the extension of health services;

Recognizing the fundamental importance of the strategies of primary care and community participation and of developing appropriate technologies, the operating capacity of national systems, and intersectoral integration, all in the framework of technical cooperation among developing countries;

Considering that, according to Resolution XXVIII of the XXIV Meeting of the Directing Council, the Ten-Year Health Plan for the Americas should be evaluated in 1980;

Considering the action plan proposed by the Director for the articulation of these actions into one single process,

RESOLVES:

- 1. To adopt the action plan proposed by the Director for articulating into one single process the evaluation of the Ten-Year Health Plan for the Americas, the analysis of the strategies applied under it, and the formulation of national and regional strategies.
- 2. To urge the Member Governments to evaluate their national health processes in the context of the Ten-Year Health Plan and analyze the strategies applied under it in the second half of 1979 and, on the basis of this review, to plot their national strategies for the goal of health for all by the year 2000.

- 3. To recommend to the Governments that, in the light of their evaluation, analysis and resultant national strategies, they make proposals for regional strategies for consideration by the Governing Bodies with a view to the adoption of the regional strategies that will constitute the contribution of the Americas to the world strategy for attaining the goal of health for all by the year 2000 as the contribution to the WHO Seventh Program of Work.
- 4. To request the Director, in addition to providing the technical cooperation that the Governments may request, to design methodological guidelines and put the proposed plan of action into effect.
- 5. To request the Director to report to the XXVI Meeting of the Directing Council on the outcome of these measures.

- 6. To request the Director to report on further progress and the perspectives of the Emergency Preparedness and Disaster Relief Coordination Program to the Directing Council at its XXVI Meeting.

Recognizing the shared social, economic and organizational interest of the Ministers of Health and of Agriculture in continuing their successful cooperation, because of the close interrelationship between human health and animal health programs;

Appreciating the satisfaction expressed by the Delegates to the RICAZ XII Meeting with PAHO's establishment of the Special Program of Animal Health and their wish to collaborate in the development of this Program, including the Pan American Foot-and-Mouth Disease Center;

Having noted that the Representatives to RICAZ XII agreed to designate that meeting henceforth as the Inter-American Meeting, at the Ministerial Level, on Animal Health; and

Recognizing that the Delegates to the XII Inter-American Meeting, at the Ministerial Level, on Foot-and-Mouth Disease and Zoonoses Control were accredited by their Governments to vote on budget proposals, and that by appproving the budgets they expressed the wish of their Governments to provide the additional financing needed to restore and expand the animal health programs of the two centers on a continuing basis,

RESOLVES:

1. To express its appreciation to the Representative of the XII Inter-American Meeting, at the Ministerial Level, on Foot-and-Mouth Disease and Zoonoses Control, for his presentation, and to the Delegates to that Meeting for their confidence in PAHO and their desire to maintain the cooperative relationships.

- 2. To recommend to the Directing Council:
- a) That it approve the amounts of US\$810,500 for 1980 and US\$906,300 for 1981 to restore and expand the operations of the Pan American Zoonoses Center.

Having examined the report "Study of WHO's Structures in the Light of Its Functions" prepared by representatives from the Governments of Ecuador, Trinidad and Tobago, and the United States of America on behalf of the Member Governments;

Bearing in mind the complexity of this study and its importance to the Region of the Americas and to the World Health Organization as a whole;

Recognizing that this study derives from the concerns expressed by the Governing Bodies of PAHO and WHO over a significant period of time;

Noting with satisfaction that the documentation calls to the attention of Member Governments a number of key issues of particular importance to the Region; and

Aware that the Member Countries can increase their benefits if they improve their receptivity to opportunities for technical cooperation offered them by PAHO/WHO,

RESOLVES:

- 1. To thank the Governments of Ecuador, Trinidad and Tobago, and the United States of America for the report (annexed to Document CE82/11).
- 2. To commend the Director and his staff for their contributions to the work of the Ad Hoc Committee.
- 3. To urge the Ad Hoc Committee and the Secretariat to develop a consolidated draft final report of the Region for presentation to, and review and approval by, the Directing Council at its XXVI Meeting.
- 4. To thank the Governments of Brazil, Ecuador, El Salvador, France, Guatemala, Mexico, Paraguay, Trinidad and Tobago, United States of America, and Venezuela, which have already responded to the questionnaire.
- 5. To urge those Governments which have not yet replied to make every effort to submit their views and comments not later than 31 July 1979 so that these can be incorporated into the regional response.

- 6. To approve the timetable, annexed to Document CE82/11, for developing the regional position.
- 7. To recommend to the XXVI Meeting of the Directing Council that it request the Director to transmit the final report on the study to the Director-General of WHO, on behalf of the Member Governments of the Region of the Americas.

IN WITNESS WHEREOF, the Chairman of the Executive Committee and the Director of the Pan American Sanitary Bureau, Secretary ex officio, sign the present Final Report in the English and the Spanish languages, both texts being equally authentic.
