PAHO AWARD FOR ADMINISTRATION, 1985

The winner of the PAHO Award for Administration, 1985, is to be chosen during the 95th Meeting of the Executive Committee of PAHO.

The Award Committee will consist of delegates of three country members of the Executive Committee (Canada, Dominica and Ecuador), who will select the winner from among five candidates nominated by four Member Governments. It is the function of the Award Committee to recommend to the Executive Committee a recipient of the PAHO Award for Administration, which will be presented in a ceremony to be held during the XXXI Meeting of the Directing Council.

Winners of the Award in Earlier Years

The winners of the PAHO Award for Administration have been as follows:

1972 Dr. Eduardo Zapata Salazar (Peru) Director of Personnel, Ministry of Health of Peru.

For this work on the preparation and implementation of a model of a personnel administration system for the health sector in his country.

1973 Mr. Guillermo Istúriz (Venezuela). Founder of the hospital administration program and of the courses in this discipline at the School of Public Health of Venezuela.

For work in the field of hospital management, which is regarded as the basis for the doctrine and practice of this field, and as having shaped the modern approach to hospital management in Venezuela.

1975 Mr. Dennis Sánchez Acuña (Costa Rica). Planning expert in the Sectoral Unit of the Ministry of Health of Costa Rica.

For his outstanding contribution to drawing up the National Health Program for 1975-1978, and particularly of the methods used to improve the development of administrative resources.

1976 Dr. Ernani Guilherme Fernandes da Motta (Brazil). Superintendent, Health Campaigns Superintendency, Ministry of Health of Brazil.

For his work in administrative management, especially in connection with the meningitis vaccination campaign in his country.

1977 Dr. Roberto Pereda Chávez (Cuba) (Posthumous). Director of the Department of International Relations, Ministry of Public Health of Cuba.

For the exceedingly salutary effects of his work on the administration and consolidation of the National Health System of his country.

1978 Dr. Oswaldo Egas Cevallos (Ecuador). General Director for Health Planning in the Ministry of Public Health of Ecuador.

For his work in the administration of health services in his country.

1980 Dr. Jair de Oliveira Soares (Brazil). Minister of Social Security, Federal Government of Brazil.

For his contribution to the organization and management of health sector services of his country, at both the regional and national levels. 1981 Dr. Frederick Burns Roth (Canada). Professor of Health Care Administration, University of Toronto, Chairman of the Council of the Home Care Program of Metropolitan Toronto.

For his work in improving the practice and teaching of health care administration both at home and abroad.

1982 Dr. Julio César Mérida de León (Guatemala). Chief, Tuberculosis Division, Ministry of Public Health and Social Welfare, Guatemala.

In recognition of his work in developing and executing programs for the prevention and control of communicable diseases and his influence in strengthening and modernizing the comprehensive administration of health services.


1983 Dr. Arnaldo Tejeiro Fernández (Cuba). National Directorate for Health Statistics, Ministry of Public Health, Cuba.

PAHO AWARD FOR ADMINISTRATION, 1985

Report of the Award Committee

The Award Committee of the PAHO Award for Administration, 1985, consisted of Dr. Lyall Black (Canada), Mrs. Jennifer Astaphan (Dominica) and Dr. Virgilio Macías Murillo (Ecuador). Dr. Lyall Black was elected Chairman; Dr. Ramón Alvarez Gutiérrez (PASB) served as Secretary.

The Award Committee met on 25 June and noted that five candidates had been nominated for the Award in 1985, as follows:

Dr. Carlos A. Alvarado, of Argentina

Dr. Alberto Aguilar Rivas, of El Salvador

Dr. Rosa Elvira Jiménez La Rosa, of Peru

Dr. Adriana Rebaza Flores, of Peru

Dr. Elizabeth Quamina, of Trinidad and Tobago

This is the sixth consecutive wear since the PAHO Award for Administration was instituted in 1969 that five or more candidates have been nominated. This fact reflects on the one hand the work by the PAHO Secretariat to publicize and promote the Award, and on the other hand the renewed and growing interest of the Member Governments of PAHO in giving recognition to those who have contributed to improve the administration of their health systems and services.

The Award Committee kept in mind the guidelines in effect for conferring the Award as set forth in the booklet PAHO Award for Administration, 1985, as well as further decision-making criteria which have been employed by other Award Committees in recent years. These criteria include: a) priority of the specific problem area or discipline (low, intermediate, or high); b) originality of the contribution (an application of existing knowledge or an application of new procedures); c) scope of the accomplishment (local, national or international); d) duration of the effect (short-, medium- or long-term); e) continuity

and consistency of the work in the course of the candidate's professional career (occasional, intermittent or permanent); f) operating level (methods and procedures, program or policy); g) personal traits, particularly in regard to leadership, communication, drive and teamwork; and h) recognition of a long and fruitful career in administration.

The Award Committee examined the documentation presented and was impressed by the excellent qualifications and achievements which were part of each candidate's background. It also felt that Member Governments should once again be urged, when nominating their candidates to PAHO, to stress clearly, succinctly and specifically the extent to which, in the Government's view, the work done by the candidate in the field of health administration has been effective and of major value.

It was the consensus of the Committee to recommend that the PAHO Award for Administration, 1985, be conferred on Dr. Elizabeth Quamina of Trinidad and Tobago for her outstanding work in health planning, administration and human resources development at the national, subregional and international levels.

Dr. Quamina's work, spanning almost three decades at the service of the Ministry of Health and Environment, has included pioneering efforts such as taking steps toward integration of curative and preventive services; laying the foundations for the application of the primary care approach in her country; and formulating the first National Health Plan of Trinidad and Tobago. Her lecturing and teaching activities, particularly at the University of the West Indies, as well as her important contributions while working closely with subregional agencies and organizations of the international system—including PAHO/WHO—constituted additional elements which led the Committee to unanimously award Dr. Quamina the PAHO Award for Administration, 1985.
