Topic 6: ARRANGEMENTS FOR THE XV PAN AMERICAN SANITARY CONFERENCE, X MEETING OF THE REGIONAL COMMITTEE OF THE WHO

B. Proposed Program of Sessions of the Conference

The Director of the Pan American Sanitary Bureau has prepared for the XV Pan American Sanitary Conference a proposed program of sessions (Annex I) in order to facilitate the work of the Conference, in accordance with the procedures followed at previous meetings. The program has been based on the draft agenda for the XV Pan American Sanitary Conference (Document CSP15/1, Rev. 2) approved by the Executive Committee at its 34th Meeting (Resolution X) with the modifications and additions subsequently introduced, as well as on the method of work defined in Resolution XVI approved by the Directing Council at its X Meeting.

The program also takes into account the recommendation of the 34th Meeting of the Executive Committee (Resolution XI) on the procedure set forth in Document CE34/13 for the presentation and study in plenary session of the Conference of the topics: "Reports of the Member States on Public Health Conditions and Progress Achieved during the Period between the XIV and XV Pan American Sanitary Conferences" (Topic 20), and "Status of Addes aegypti Eradication in the Americas" (Topic 21). Also, in accordance with the proposed rules for Technical Discussions (Document CE34/13, Annex I, Rev. 1), one day has been set aside, approximately midway in the course of the Conference, for the special session of the Technical Discussions on the topic "The Prevention of Accidents in Childhood".

Daily sessions of the General Committee have been scheduled for the afternoons, following the sessions of the main committees. The General Committee may in this way establish the order of business for the plenary sessions, taking into account the status of work in each of the main committees. Likewise, to facilitate both the progress of the deliberations and the work of the secretariat, it is deemed advisable that the rapporteurs of the main committees present to the Conference their oral and written reports as the respective committees approve resolutions on each of the topics assigned them by the General Committee.

The proposed program of sessions is submitted to the Executive Committee for consideration, so that, if approved, it may be transmitted to the Conference for adoption. The General Committee of the Conference will have the function of distributing the topics among the committees and of scheduling the dates for examination of the various agenda items in plenary sessions of the Conference.
