ANALYSIS OF THE MANDATES OF THE PAN AMERICAN HEALTH ORGANIZATION

Introduction

1. In 2013, during its 153rd Session, the Executive Committee requested that the Pan American Sanitary Bureau (“the Bureau”) develop a tool for organizing and systematizing the mandates of the Pan American Health Organization (PAHO) that would enable the Member States and other stakeholders to monitor progress on international commitments to public health.
2. The Executive Committee also requested that the Bureau organize the information on the resolutions and documents approved by the Governing Bodies of PAHO consistent with the PAHO Strategic Plan. This arrangement of the information would make it possible to analyze the complementarity and execution of the mandates issued by PAHO over time.
3. In 2014 the Bureau presented a report to the 53rd Directing Council of PAHO, 66th Session of the Regional Committee of the World Health Organization (WHO) for the Americas (Document CD53/INF/5), on the assessment done by the Bureau on the resolutions adopted by PAHO over a period of 15 years (1999-2013) in order to determine whether these resolutions could be classified as “active,” “conditional active,” or “sunset”. The report also included information on the PAHO/WHO Institutional Repository, a digital documentation system for preserving and searching institutional memory (1).
4. After the presentation of said report, the Directing Council requested to the Bureau to perform a deeper analysis of the resolutions, and to present to the Governing Bodies, in the future, another report including a proposed resolution, in order to decide which resolutions could be considered as sunset, conditional active, or active.

5. This document presents a detailed assessment of the resolutions adopted by PAHO over a period of 17 years (1999-2015). It also includes a proposed resolution with specific recommendations for sunseting resolutions, or maintaining them as active or conditional active.

Analysis of PAHO Resolutions (1999-2015)

6. For the purpose of this study, the Director commissioned the office of the Deputy Director to form an interprogrammatic working group comprised of representatives from all the departments. The working group used as background information, the report presented to the 53rd Directing Council in 2014 (1), the WHO reform report (2), and the Twelfth General Program of Work, 2014-2019 approved by the World Health Assembly in May 2013 (3); as well as similar exercises conducted by the WHO Regional Offices in Europe (EURO) (4) and the Eastern Mediterranean (EMRO) (5).

Methodology

7. The working group developed the following methodology to analyze the resolutions adopted by the Directing Council and the Pan American Sanitary Conference:

- a) Determine the period of analysis of resolutions (1999-2015).
- b) Establish criteria for determining whether a resolution can be classified as active, conditional active, or sunset (see Table 1).

Table 1. Criteria for Determining the Classification of Resolutions

Active	Conditional Active	Sunset
All resolutions whose stipulated lifespan remains in effect.	All resolutions whose lifespan has ended, but it is unknown whether compliance with some commitment is pending, due to a lack of information at the time of the study or some other reason.	All resolutions that, by their very nature, do not require subsequent monitoring (e.g., approval of the scale of quota assessments; approval of the Director's salary or modifications to the Staff Rules or Financial Rules and Regulations).
All resolutions whose commitments have not been met or renewed in a subsequent resolution and whose continuity is deemed relevant¹ and important.	All resolutions that are no longer relevant, even though some of their commitments have not been met.	All resolutions whose lifespan has ended ² and/or whose commitments are considered to have been met ³ or have been revisited in a subsequent resolution.

¹ For the purposes of this study, a resolution is considered to be relevant if it meets one or more of the following criteria: *a)* the subject is included in the PAHO Strategic Plan 2014-2019; *b)* the preamble section of the resolution is still valid; *c)* it is explicitly related to the global mandates of an international organization of importance to PAHO; *d)* it calls for PAHO technical cooperation at the regional level.

² When the resolution or the document endorsed by the resolution clearly stipulates the lifespan and the commitments are met or are no longer considered relevant (see criteria for relevance in footnote 3).

Active	Conditional Active	Sunset
		All resolutions whose lifespan has not been stipulated, but the conditions that gave rise to them are considered to have changed, making them irrelevant.
		All resolutions that have been superseded by another more recent one.

- c) Base the review on the categories and program areas of the PAHO Strategic Plan 2014-2019 (see Annex A).
- d) Analyze the resolutions according to the following aspects:
- i. Lifespan: whether the resolution or document endorsed by the resolution explicitly includes time-marked information.
 - ii. Replacement: whether the resolution was superseded by another more recent one, in which case the one that superseded it shall be noted.
 - iii. Compliance with mandates: whether each commitment established for the Bureau and the Member States has been met or whether the mandate remains in force. If information was unavailable at the time of the study, this shall be stated in the report.
 - iv. Progress reports: whether the resolution or the document endorsed by the resolution stipulates the periodicity with which progress reports must be submitted. If so, it shall be determined whether the reports were submitted as stipulated.
- e) Issue a recommendation for each resolution pursuant to its findings, and submit the recommendations and analysis to the Director for review.
- f) Submit a report on the study of resolutions to the 55th Directing Council of PAHO, 68th Session of the Regional Committee of WHO for the Americas in September 2016.
8. Resolutions were classified by category of the PAHO Strategic Plan 2014-2019, and were reviewed from the oldest to the newest. For those resolutions pertaining to cross-cutting categories, the working group placed them in the category in which they had the highest number of mandates, but examined the resolution in an interprogrammatic way.

³ The working group shall review all operative paragraphs in each resolution and determine whether each commitment made by the Member States and Bureau has been met, whether there is no information at the time of the study, or whether the commitment remains in force.

Results

9. The assessment concluded that a total of 287 resolutions were adopted by the PAHO Directing Council and the Pan American Sanitary Conference in the 17-year period of 1999-2015. Annex B contains a summary report of all the resolutions by category, including the number, title, year of adoption and finalization, type of document, reporting requirement, progress reports presented to the Governing Bodies, recommendation, and justification for the recommendation. It also identifies when any of the information was not available. It also identifies a proposal for consideration by the Governing Bodies.

10. The complete assessment, including a consolidated record of the Bureau's and Member States' commitments over the past 17 years, will be available in English in the PAHO/WHO Institutional Repository.⁴

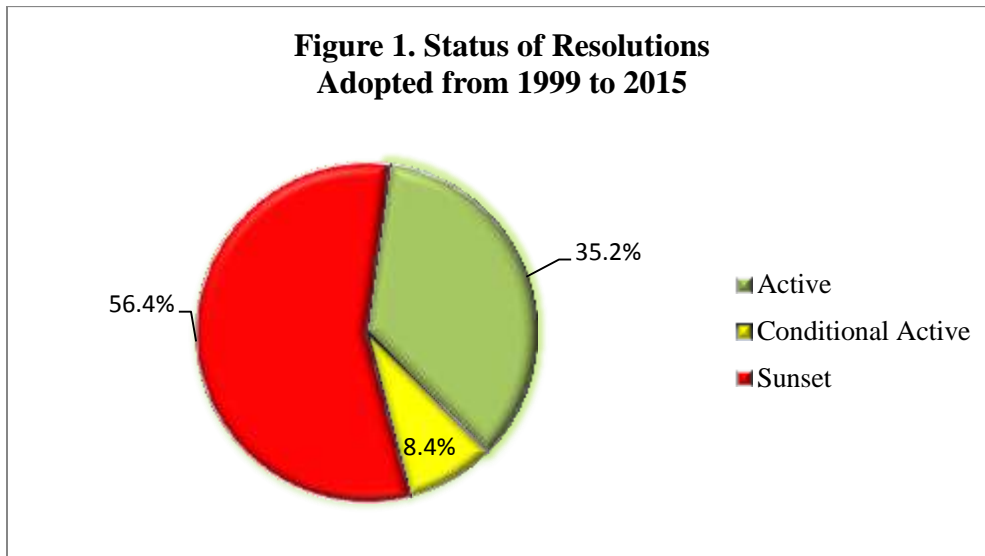
11. Each resolution was examined mandate by mandate. In most cases, the Bureau was able to identify progress made in mandates applicable to the Bureau. However, regarding the Member States mandates, in some instances sufficient information on compliance was not available.

12. A summary of the results of the review is displayed in Table 2 organized by the categories of the PAHO Strategic Plan 2014-2019.

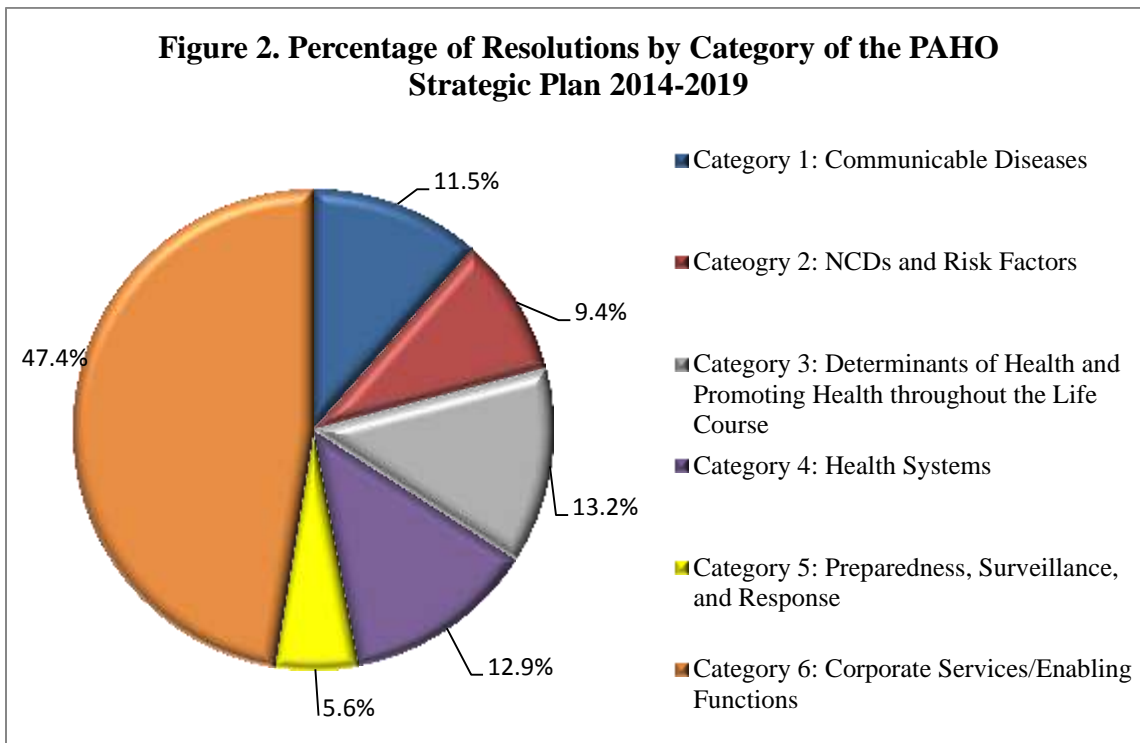

13. According to the defined methodology and as shown in Figure 1, the working group proposes to maintain 101 resolutions active (35.2%), maintain 24 conditional active (8.4%), and sunset 162 (56.4%). For those resolutions with a conditional active status, the Bureau is proposing to the Governing Bodies the way forward in order to deal with the pending mandates.

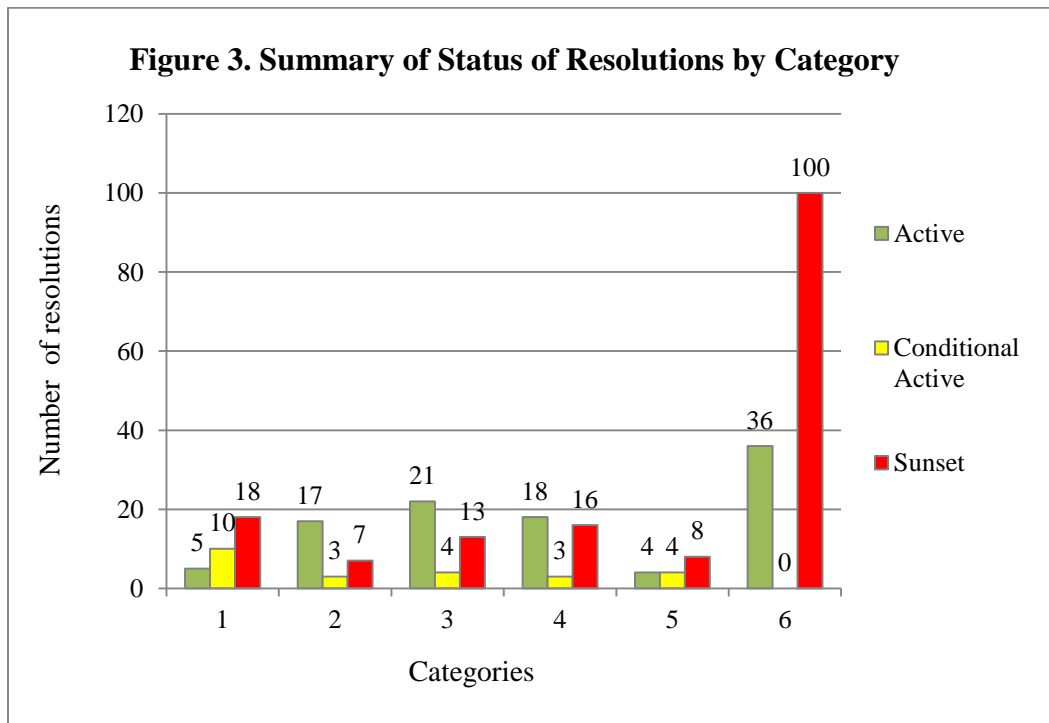


14. As shown in Figure 2, out of the total 287 resolutions, Category 6, Corporate Services/Enabling Functions had the highest number of resolutions (136, or 47.4%); followed by Category 3, Determinants of Health and Promoting Health throughout the Life Course (38, or 13.2%); Category 4, Health Systems (37, or 12.9%); Category 1, Communicable Diseases (33, or 11.5%); Category 2, Noncommunicable Diseases and Risk Factors (27, or 9.4%); while Category 5, Preparedness, Surveillance, and Response had the lowest number (16, or 5.6%).



15. The recommendations of the working group, as shown in Figure 3 below, are as follows:

- a) In Category 1, sunset 18 resolutions (54.5% of the resolutions in this category), maintain 5 active (15.2%), and maintain 10 as conditional active (30.3%).
- b) In Category 2, sunset 7 resolutions (25.9% of the resolutions in this category), maintain 17 active (63%), and maintain 3 as conditional active (11.1%).
- c) In Category 3, sunset 13 resolutions (34.2% of the resolutions in this category), maintain 21 active (55.3%), and maintain 4 as conditional active (10.5%).
- d) In Category 4, sunset 16 resolutions (43.3% of the resolutions in this category), maintain 18 active (48.6%), and maintain 3 as conditional active (8.1%).
- e) In Category 5, sunset 8 resolutions (50% of the resolutions in this category), maintain 4 active (25%), and maintain 4 as conditional active (25%).
- f) In Category 6, sunset 100 resolutions (73.5% of the resolutions in this category), maintain 36 active (26.5%), and maintain 0 as conditional active.



16. The working group considered it necessary to separate the analysis of “sunset” resolutions in Categories 1 to 5 from Category 6 because categories 1 to 5 deal more with technical cooperation. Of the 62 resolutions which the working group considered as “sunset” in Categories 1 to 5, 56 were superseded by another resolution (and thus the pending mandates continue to be active in a more recent resolution); the remaining 6 have expired, have commitments that have been met, or are no longer relevant. In the

case of Category 6, out of the 100 resolutions proposed for sunset, 66 were superseded by another resolution, and 34 are resolutions that do not require subsequent monitoring, have expired or have commitments that have been met.

17. Of the 24 resolutions which the working group considered as “conditional active,” 21 are expected to be superseded or finalized between 2016 and 2017; the remaining three include a recommendation by the Bureau for the way forward.

Conclusions

Limitations

18. The working group found some limitations in determining compliance of mandates by Member States and by the Bureau, especially regarding the oldest resolutions. Until recently, resolutions and documents did not include the specification of the type of document (policy, strategy, plan of action, or other). For these cases, the working group used the current classification followed by PAHO’s Governing Bodies whenever possible. Another weakness in older resolutions and documents was the lack of information on reporting requirements and on financial implications.

Recommendations

19. Although there is a notable improvement in the harmonization of documents and resolutions in the last years, there is still the need to strengthen the focus of PAHO initiatives and mandates towards the achievement of the Strategic Plan and the Health Agenda for the Americas. In order to be more transparent and accountable, future resolutions need to be more explicit in including reporting requirements, clear mandates, capacity for implementation, and financial implications.

20. It is also recommended that PASB maintain the monitoring of resolutions on a permanent basis in order to follow up on the compliance of mandates, and present reports to the Governing Bodies every three years with a proposed resolution to sunset resolutions when appropriate.

Action by the Directing Council

21. The Directing Council is invited to take note of this report, formulate the recommendations it deems pertinent, and consider the approval of the proposed resolution in Annex C.

PROPOSED RESOLUTION

ANALYSIS OF THE MANDATES OF THE PAN AMERICAN HEALTH ORGANIZATION

THE 55th DIRECTING COUNCIL,

(PP1) Having reviewed the report on the *Analysis of the Mandates of the Pan American Health Organization* (Document CD55/18), regarding the status of resolutions adopted by the Directing Council and the Pan American Sanitary Conference in their capacity as Regional Committee of WHO for the Americas during the past 17 years (1999–2015), as well as recommendations for sunseting and reporting requirements;

(PP2) Noting that a number of resolutions have an open-ended requirement for reporting back to the Governing Bodies,

RESOLVES:

(OP)1. To endorse the recommendations made in *Analysis of the Mandates of the Pan American Health Organization* (Document CD55/18) for sunseting resolutions and reporting, that is, to establish a practice of time-limited reporting and to sunset the resolutions that have been superseded in their entirety by subsequent resolutions, or whose commitments are considered to have been met.

(OP)2. To request the Director to:

- a) continue the practice of defining the requirements for reporting on the implementation of resolutions, with a specific end date for reporting back to the Directing Council or the Pan American Sanitary Conference;
- b) present similar analyses of resolutions at least every three years in order to sunset resolutions as appropriate.
