### Topic 25: NAME OF THE ORGANIZATION AND TITLES OF ITS SENIOR OFFICERS

The Executive Committee, at its 34th Meeting (Washington, D.C., May 1958) agreed to recommend to the XV Pan American Sanitary Conference certain amendments to the Constitution of the Pan American Sanitary Organization relating to the name of the Organization and to the titles of its senior officers. These recommendations are contained in Resolutions XIII and XIV adopted by the Committee after a detailed study of Document CE34/7, in which the Director submitted several alternatives in connection with this topic (see Annex).

1. Resolution XIII, which refers to the name of the Pan American Sanitary Organization, reads as follows:

"The Executive Committee,

Bearing in mind that the word 'sanitary' in the name of the Pan American Sanitary Organization does not express fully or accurately the character of the Organization or its functions in the broad field of health, as established in Article 1 of the Constitution;

Considering that the substitution of the word 'health' for 'sanitary' in the name of the Organization, in the four official languages (in English, Pan American Health Organization; in French, Organisation panaméricaine de la Santé; in Portuguese, Organização Pan-Americana da Saúde; and in Spanish, Organización Panamericana de la Salud), would correct this situation and, by promoting a better understanding of the Organization's activities, would gain greater support on the part of the general public; and

Considering the provisions of Article 25 of the Constitution,

#### RESOLVES:

To recommend to the XV Pan American Sanitary Conference that it consider the following amendment to the Constitution of the Crganization:

Replace the name 'Pan American Sanitary Organization' by 'Pan American Health Organization' in Articles 1, 2-A, 3, 19-B and 21-A."

2. Resolution XIV, which refers to the titles of senior officers of the Pan American Sanitary Bureau, reads as follows:

"The Executive Committee,

Considering that the present titles of the senior officers of the Pan American Sanitary Bureau are ambiguous and do not reflect accurately the functions and activities of those officers:

Considering the advisability of adopting generally-accepted titles that will be self-descriptive insofar as the responsibilities of the particular post are concerned; and

Considering the provisions of Article 25 of the Constitution,

#### RESOLVES:

To recommend to the XV Pan American Sanitary Conference that it consider the following amendments to the Constitution of the Organization:

- a. Revise the text of Article 4-E to read: 'The Conference shall elect the Director of the Pan American Health Organization by a two-thirds vote of the countries represented and with the right to vote. The Director shall be the chief technical and administrative officer of the Organization and the legal representative thereof. In case of resignation, incapacity, or death of the Director between meetings of the Conference, the Directing Council shall elect a Director who shall act ad interim.'
- b. Revise the text of Article 18-A to read: 'The Pan American Sanitary Bureau shall be headed by the Director designated in accordance with the provisions of Article 4, paragraph E. In the event of the resignation, incapacity or death of the Director, the Deputy Director shall assume his duties until the next meeting of the Council.'
- c. Eliminate the words 'of the Pan American Sanitary Bureau' (or 'of the Bureau') after the title 'Director' in Articles 4-B, 8-B, 8-C, 9-D, 10-B, 10-C, 12-A, 12-C, 14-A, 18-C, 20, and 24-A.

- d. Revise the first sentence of Article 18-B to read: 'There shall be a Deputy Director and an Assistant Director appointed by the Director with the approval of the Executive Committee.'
- e. Add the following sentence at the beginning of Article 17:
  'The Pan American Sanitary Bureau is the General Secretariat
  of the Pan American Health Organization.'

In conformity with the above, Resolutions XIII and XIV are transmitted to the Conference.

Topic 14: NAME OF THE ORGANIZATION AND TITLES OF ITS SENIOR OFFICERS

### A. Use of the Term "Health" instead of "Sanitary" in the Name of the Organization

The term "sanitary" in the history of the Pan American Sanitary Organization dates from the period 1902, when the principal functions of international health related to international sanitary regulations. Today, the Organization's objective covers the broad concept of health as stated in Article 1 of the Constitution: "to promote and coordinate efforts of the countries of the Western Hemisphere to combat disease, lengthen life, and promote the physical and mental health of the people."

Because of its restricted meaning in present-day usage, the word "sanitary" does not describe fully or accurately these basic purposes, and the experience of recent years has shown that its continued use in the name of Pan American Sanitary Organization represents an obstacle to disseminating information to the public on the work of the Organization. In many instances, the nature and activities of Pan American Sanitary Organization are misunderstood or incorrectly identified because of confusion deriving from its designation as a "sanitary" organization.

To avoid this confusion, and to promote a better understanding of the Organization's work, the Executive Committee may wish to consider the advisability of recommending that the word "health" be substituted for "sanitary" in the name of the Pan American Sanitary Organization. This change in no way affects the historic name of the Pan American Sanitary Bureau as set forth in the Pan American Sanitary Code of 1924, a treaty ratified by all the American republics. Adopting the term "health" for the Organization while retaining "sanitary" for the Bureau would, in fact, avoid the confusion that now arises from the very similarity of the names Pan American Sanitary Organization and Pan American Sanitary Bureau.

After considering the foregoing, the Executive Committee may wish to present to the XV Pan American Sanitary Conference a recommendation along the following lines:

### Proposed Resolution

The Executive Committee,

Bearing in mind that the term "sanitary" in the name of the Pan American Sanitary Organization does not describe fully or accurately the character of the Organization or its functions in the broad field of health, as established in Article 1 of the Constitution;

#### RESOLVES:

To recommend to the XV Pan American Sanitary Conference that it consider the following amendment to the Constitution of the Organization:

Replace the name "Pan American Sanitary Organization" by "Pan American Health Organization" in Articles 1, 2-A, 3, 19°B, and 21-A.

#### B. Titles of Senior Officers of the Organization

The Constitution of the Organization provides for both a Director and a Secretary General of the Pan American Sanitary Bureau. This is confusing since in other international organizations such as the Organization of American States and the United Nations, the Secretary General exercises functions equivalent to those of the Director in the Bureau, both as chief administrative officer and as legal representative of the respective organization.

To avoid the confusion that arises from using both titles and to facilitate public and professional understanding of the status and functions of the senior officers of the Organization, the Executive Committee may wish to consider presenting to the XV Pan American Sanitary Conference possible changes in the titles. The following alternatives are possible:

- 1. That the title Secretary General be used to designate the chief technical and administrative officer of the Organization and the legal representative thereof, in which case the officers designated under the Constitution as Assistant Director and Secretary General would have the titles of Deputy Secretary General and Assistant Secretary General, respectively, or;
- 2. That the title Secretary General be eliminated, in which case the title Director would be used to designate the chief technical and administrative officer of the Organization and the legal representative thereof, and the officers designated under the Constitution as Assistant Director and Secretary General would have the titles of Deputy Director and Assistant Director, respectively.

The Executive Committee may wish to consider a resolution along the following lines:

Bearing in mind that, in the Organization of American States and in the United Nations, the title of Secretary General is used to designate the officer who, as chief administrative officer and legal representative of the respective organization, exercises functions equivalent to those exercised by the Director in the Pan American Sanitary Bureau; Considering that the present titles of the senior officers of the Pan American Sanitary Bureau are ambiguous and do not reflect accurately the functions and activities of those officers;

Considering the advisability of adopting generally-accepted titles that will be self-descriptive insofar as the responsibilities of the particular post are concerned; and

#### RESOLVES:

To recommend to the XV Pan American Sanitary Conference that it consider the following amendments to the Constitution of the Organization:

In case of resignation, incapacity, or death of the Secretary General between meetings of the Conference, the Directing Council shall elect a Secretary General who shall act ad interim."
- o. Revise the text of Article 18-A to read: "The Pan American Sanitary Bureau shall be directed by the Secretary General designated in accordance with the provisions of Article 4, paragraph E. In the event of the resignation, incapacity, or death of the Secretary General, the Deputy Secretary General shall assume his duties until the next meeting of the Council."
- c. Replace the title "Director of the Pan American Sanitary Bureau" (or "Director") by "Secretary General," in Articles 4-B, 7-A, 7-C, 7-D, 8-B, 8-C, 9-D, 10-B, 10-C, 12-A, 12-C 14-A, 18-C, 19-B, 20, 22, and 24-A.
- d. Revise the text of the first two sentences of Article 18-B to read: "There shall be a Deputy Secretary General and an Assistant Secretary General appointed by the Secretary General with the approval of the Executive Committee. The Secretary General shall also appoint all personnel of the Pan American Sanitary Bureau."

e. Add the following sentence at the beginning of Article 17:
"The Pan American Sanitary Bureau is the General Secretariat
of the Pan American Health Organization."

REPORT ON PROPOSED CHANGES IN THE CONSTITUTION OF THE PAN AMERICAN SANITARY ORGANIZATION, SUBMITTED BY THE COMMITTEE ON INTER-AMERICAN ORGANIZATIONS

At the meeting of June 30, 1958, the Council of the Organization requested the Committee on Inter-American Organizations to study the changes in the Constitution of the Pan American Sanitary Organization that the 34th Meeting of the Executive Committee of that Organization had agreed to submit to the XV Pan American Sanitary Conference, to be held in San Juan, Puerto Rico, September 21-October 6 of this year.

The Committee has studied the proposed changes, taking into account Article XIX of the Agreement Between the Council of the Organization of American States and the Directing Council of the Pan American Sanitary Organization, and Articles 97 and 53.b of the Charter of the Organization. These articles read as follows:

#### Article XIX of the Agreement

Whenever a project contemplating substantial changes in the scructure or financial basis of the Pan American Sanitary Organization is to be submitted to the competent organ of that Organization, it will first be submitted in due time to the Council of the Organization of American States.

#### Article 97 of the Charter

The Specialized Organizations shall enjoy the fullest technical autonomy and shall take into account the recommendations of the Council, in conformity with the provisions of the present Charter.

#### Article 53.b

(It is also the duty of the Council:)

(b) To draft recommendations to the Governments, the Inter-American Conference, the Specialized Conferences or the Specialized Organizations, for the coordination of the activities and programs of such organizations, after consultation with them.

The 34th Meeting of the Executive Committee of the Pan American Sanitary Organization recommended to the XV Pan American Sanitary Conference that it study certain amendments to the Constitution of the Organization designed to change the name "Pan American Sanitary Organization" to "Pan American Health Organization" (Resolution XIII), and to change the titles of the high officials of the Pan American Sanitary Bureau so that they will conform with those in general use and of themselves provide some concept of the duties of the positions to which they refer.

While the Committee on Inter-American Organizations has no recommendations on the aforesaid changes to make to the Council, it does believe this to be an opportune time to suggest that when the XV Pan American Sanitary Conference is studying Article 4-E of the Constitution of the Pan American Sanitary Organization it consider the desirability of setting forth in the aforesaid article the length of the term of office of the Director of the Organization.

In accordance with the foregoing considerations, the Committee on Inter-American Organizations herewith submits the following draft resolution to the Council: 1/

THE COUNCIL OF THE ORGANIZATION OF AMERICAN STATES,

HAVING SEEN the report on proposed changes in the Constitution of the Pan American Sanitary Organization, submitted by the Committee on Inter-American Organizations,

#### RESOLVES:

- 1. To state that it has no recommendations to make on the aforesaid changes.
- 2. To suggest to the XV Pan American Sanitary Conference that, in considering Article 4-E of the Constitution of the Pan American Sanitary Organization, it specify the length of the term of office of the Director of the Organization.
- 3. To request the Secretary General of the Organization of American States to transmit this resolution to the Pan American Sanitary Organization.
