#### COVID-19 - Highlights

- 1. According to a 29 March CDC Morbidity and Mortality Weekly Report (MMWR), mRNA vaccine effectiveness of full immunization (≥14 days after second dose) was 90% against SARS-CoV-2 infections regardless of symptom status; vaccine effectiveness of partial immunization (≥14 days after first dose but before second dose) was 80%. The study was conducted amongst prospective cohorts of 3,950 health care personnel, first responders, and other essential and frontline workers who completed weekly SARS-CoV-2 testing for 13 consecutive weeks. - 2. Due to the continued acceleration in cases and deaths, Paraguay Ministry of Health (MoH) announced that travelers going to Brazil must return with a negative PCR test to enter the country or sign an affidavit that they will undergo the test within 24 hours. The control will be carried out at the Friendship Bridge. There are concerns that the virus could spread to the interior of the country where there are currently low numbers of infections. #### Spotlight - SARS-COV-2 Variants of Concern (VOC) in the Americas

Today's spotlight provides an update on the geographical distribution of three variants of concern including VOC 20212/01; 501Y.V2 and P1 of the SARSCoV-2 virus (as reported by countries, territories, and areas (hereafter countries) in the region of the Americas as of 22 March 2021. Since the last update on 22 March, one new country/territory detected at least one of the three VOCs – Paraguay.










**Argentina**: On 14 March 2021, due to daylight savings time observed in Eastern Standard Time zone, the Argentina data is no longer published by 3:00PM EST same day and is henceforth included in the following day table. Between 22 February and 14 March 2021, the data had corresponded to the same date.

**Bahamas**: According to a 27 March Bahamas Ministry of Health (MoH) publication, there are a total of 15 additional deaths under investigation, available at: https://bit.ly/3noOhKK

**Ecuador**: According to a 6 September Ecuador Ministry of Public Health press release, only cases confirmed by RT-PCR will be reported; previously, cases who tested positive by either RT-PCR or RDTs were reported, resulting in the exclusion of 8,956 cases. Available at: https://bit.ly/3h2EWEA

**Guadeloupe**: Deaths are aggregated for Guadeloupe and Saint Martin in Sante Publique France weekly publications, available at: https://bit.ly/2VQ201g. **Peru**: Aggregated case total as reported by the Peru MoH; disaggregated data posted as of 27 March 2021 is 451,025 by RT-PCR + 198,434 by antigen tests + 871,514 by other RDTs. **Puerto** Rico: Aggregated case total as reported by the Puerto Rico Department of Health (DoH); 97,282 were positive by RT-PCR and 9,206 were positive by antigen tests; previously, cases who tested positive by either RT-PCR or serological RDTs were reported, resulting in the exclusion of 33,965 cases. **Uruguay**: According to the 28 March 2021 Uruguay Ministry of Public Health report, 20 positive cases reported in the last 24 hours were excluded from the total, available at: https://bit.ly/3wapgb5. **DATA ADJUSTMENTS:** Differences in the total number of cases and/or deaths and respective % increases reflect the following adjustment:

Anguilla: Total cases were retrospectively adjusted for 28 March 2021 in order to align with data reported by the Anguilla Ministry of Health indicating 25 cases. Available at: https://bit.ly/31rb4wg
