PROVISIONAL AGENDA OF THE SEVENTY-THIRD SESSION OF THE EXECUTIVE BOARD OF WHO: ITEMS OF INTEREST TO THE REGIONAL COMMITTEE

The Director is pleased to transmit to the XXIX Meeting of the Directing Council the tentative provisional agenda of the Seventy-third Session of the Executive Board of the World Health Organization, to be held in Geneva, Switzerland, in January 1984. Currently, the countries from the Region of the Americas entitled to designate a person to serve on the Executive Board are: Argentina, Chile, Panama, Trinidad and Tobago, United States of America, and Venezuela.

In compliance with Resolution XIX of the XXI Panamerican Sanitary Conference (1982) a briefing session was held on 7 January 1983 for members of the Board from the Region of the Americas. The session was attended by members from Brazil, Canada, Guatemala, and the United States of America. Briefing materials were also sent to members from Chile and Trinidad and Tobago at Geneva. Most of the members who participated in the briefing indicated that such session constituted a useful idea and that they should continue in the future, preferably in Geneva.

As of this writing there are no background documents available on most Executive Board agenda items; in fact, certain documentation depends on the meeting of the Program Committee of the Executive Board scheduled for later in the year. Nevertheless, the following items on the Provisional Agenda of the Executive Board may be highlighted to the extent that they might be of interest to the mebers of the Directing Council of PAHO.

- Item 8.2: "Members in arrears in the payment of their contributions to an extent which may involve Article 7 of the Constitution."
- Item 10: "Reports of the Regional Directors on significant regional developments, including regional committee matters."
- "Global strategy for Health for All by the Year 2000: Report on monitoring of progress in implementing strategies for health for all." The Council will consider a preliminary report on the situation in the Americas in connection with Health for All (Item 21, Document CD29/24).
- Ttem 12: "WHO Advisory Committees on Medical Research." The Directing Council will consider the report of the PAHO ACMR (Item 29, Document CD29/14).
- "Action Programme on Essential Drugs." The Technical Discussions at the XXIX Meeting of the Directing Council will analyze "Policies for the Marketing of Essential Drugs" (Document CD29/DT/1).
- Item 15: "Action in respect of international conventions on narcotic drugs and psychtropic substances." Under Item 25 of its own Provisional Agenda, the Council will discuss a report on Drug Abuse Prevention. (Document CD29/22).
- Item 17.1: "Restructuring the Technical Discussions." PAHO will also be discussing a similar issue under Item 19 of the Council's agenda (Document CD29/8).
- Ttem 26: "Provisional agenda for and duration of the Thirty-seventh World Health Assembly." The Council may examine—as Regional Committee—the general procedures and duration of the Assemblies, in connection with the functioning of the Governing Bodies of WHO.

The Directing Council may wish to consider the Provisional Agenda of the Seventy-third Session of the Executive Board in the context of the continuing efforts to coordinate the meetings and the actions of all the Governing Bodies of the Organization. Should it deem it necessary, the Council may suggest certain topics on the agenda of the Board—or relevant PAHO resolutions, documentation and activities—as worthy of the attention of the persons from the Americas who serve on the Board.
